NOTICE TO ALL ENROLLED STUDENTS OF REGENCY BEAUTY INSTITUTE AT THE TIME OF CLOSURE

November 9, 2016

The State Council of Higher Education for Virginia (SCHEV) is providing important information to students who were enrolled at Regency Beauty Institute at the time of its closure on September 28, 2016. It will supplement information provided by Regency Beauty Institute regarding choices available to students displaced by its precipitous closure.

All students enrolled at Regency Beauty Institute at the time of closure will receive a copy of this letter via email or US mail. In addition, in the event all students cannot be reached, SCHEV has posted this information on its website to ensure students have access to this important information.

We hope that students have found new schools to complete their studies. However, if you have not, please read the important information below. The following options are available to students enrolled in Regency Beauty Institute at the time of closure:

1. SCHEV has obtained the academic records (transcripts) from the Regency Beauty Institute, you can obtain a free copy of your transcript through the end of this year. At the beginning of next year, there will be a fee associated with requesting a record. 3. Students who paid tuition directly to the school (out-of-pocket) and will not pursue a transfer to another institution have the option to file a claim for unearned tuition.
